## **African Ministerial Conference on the Environment**

Seventh special session and first meeting of the Africa Environment Partnership Platform

Nairobi, 17 – 21 September 2018

# Information note on the seventh special session of the African Ministerial Conference on the Environment and the first meeting of the Africa Environment Partnership Platform

## Introduction

The African Ministerial Conference on the Environment (AMCEN) meetings provides guidance with respect to key regional policies and initiatives related to the environment. Pursuant to this, the seventh special session of AMCEN will be held at the headquarters of the United Nations Environment Programme in Gigiri, Nairobi, Kenya from 17 to 21 September 2018. It will consist of a meeting of the expert group to be held from 17 to 18 September 2018, a ministerial segment to be held on 19 September 2018.

The special session is jointly organized with the NEPAD Agency and will be held back to back with the first meeting of the Africa Environment Partnership Platform which will take place on 20 and 21 September 2018 at the same venue. The aim of the Africa Environment Partnership Platform is to promote sustainable environmental management in Africa through enhanced partnership, coordination and harmonization of activities.

The AMCEN special session will consider key issues to be discussed at the fourth United Nations Environment Assembly (UNEA-4) and Africa's common approach for engagement in the Assembly, scheduled to take place from 11-15 March 2019. The theme of UNEA-4 is "Innovative solutions for environmental challenges and sustainable consumption and production". The theme Innovative solutions, covering policies, financing, technologies, partnerships and multi-stakeholder processes – are key both to solving many environmental challenges, as well as to accelerating sustainable development more generally. The special session will therefore focus on how environmental challenges can be addressed through innovative solutions and interventions and by promoting sustainable consumption and production. The session will therefore be held under the overall theme of "Turning Environmental Policies into Action through Innovative Solutions".

The special session will provide an opportunity for the region to prepare for the 14<sup>th</sup> Conference of the Parties to the United Nations Convention on Biological Diversity (CBD-COP14) scheduled for 17 to 29 November in Sharm el Sheikh, Egypt. The conference of the parties will address a wide range of agenda items, including review of progress in the implementation of the Convention and the Strategic Plan for Biodiversity 2011-2020. Egypt is also planning to organize a high-level event (African Biodiversity Summit) back to back with COP14 as endorsed by AMCEN at its 16<sup>th</sup> Regular Session. The regional groups, including Africa, are expected to report to the Conference of the Parties on the results of regional preparatory meetings held prior to the fourteenth meeting of the Conference of the Parties. The special session will help the region to agree on how to engage and speak with a common voice at the Conference of the Parties.

The seventh special session of AMCEN will also focus on the 24th Conference of the Parties to the United Nations Framework Convention on Climate Change (UNFCCC-COP24) to be held in Katowice, Poland later in the year. 2018 will be an important year for international climate diplomacy as nations move forward to implement the Paris Climate Change Agreement – indeed 2018 is when governments are expected to reach some key milestones. These range from finalizing the guidelines for fully operationalizing the agreement, to taking stock of how countries are doing collectively in terms of being on track to realize Paris's aims and ambitions over the coming years and decades. The special session will therefore provide a forum for the African region to agree on its key messages and strategies for negotiations at the Conference of the Parties.

It will be recalled that AMCEN at its 14<sup>th</sup> session held in 2012 adopted a decision to establish an African Environment Partnership Platform spearheaded by the NEPAD Agency. The Platform was officially launched during the 22<sup>nd</sup> Conference of the Parties to the UN Framework Convention on Climate Change (UNFCCC COP22) in Marrakech, Morocco in 2016. Subsequently, the steering committee of the partnership platform agreed to hold the first meeting of the platform in 2018. The focus for this first meeting of the platform will be to review environmental management in Africa under the theme "50 years of Environmental Governance and Sustainability in Africa". It is expected that the platform meeting will conclude with a communique, whose content will form part of the final outcomes of the special session. An awards ceremony is planned for the evening of 19 September 2018 to recognize countries, institutions and individuals who have played key roles and contributed significantly towards the management of Africa's environmental assets.

The Ministers and experts will adopt a declaration, a set of decisions and key messages reflecting the discussions under the various issues on the agenda.

#### VISITORS TO KENYA

## **General Information**

The Republic of Kenya is located on the Eastern coast of Africa and is bisected by the Equator. It is a land of striking landscapes, ranging from snow-capped Mount Kenya to rich farmlands, barren deserts in the north and tropical sandy beaches on the western Indian Ocean coast and the shores of lakes Turkana and Victoria.

Kenya borders Somalia to the North East, Ethiopia and South Sudan to the North, Uganda to the West, Tanzania to the South, and the Indian Ocean to the East. Kenya's capital city is Nairobi with a population of about 4 million people. Other major cities are Mombasa, the main seaport on the Indian Ocean, and Kisumu on the Lake Victoria front. Kenya is one of the world's most popular tourism destinations attracting millions of tourists over the past years. The country is endowed with attractive tourist sites, rich culture, biological diversity, striking geographical diversity and landscapes ranging from beautiful beaches, to wildlife reserves and archaeological sites.

#### Jomo Kenyatta International Airport (JKIA) in Nairobi

The Airport is located 15 kilometres from Nairobi's central business district and 25 kilometres from the United Nations Office at Nairobi, Gigiri.

Kenya is GMT + 0300 hours

## Visas

It is the responsibility of each participant to obtain a visa for Kenya. The information provided herein acts only as guidance. A valid passport, not expiring for at least six months from date of arrival is required for entry into Kenya.

A valid entry visa is also required for most countries and may be obtained in advance from the Kenyan Embassy/High Commission in your country of residence. In the absence of either, the British Embassy will generally represent Kenya in the issuance of visas. For more information. Please visit: http://www.immigration.go.ke/Information.html. If needed, but under exceptional circumstances, it is still possible to obtain visas upon arrival at Jomo Kenyatta International Airport in Nairobi. The fee is USD 50 for a one-time (single) entry. Please note that visas are not required for citizens of: Botswana, Burundi, Ghana, Lesotho, Malawi, Mauritius, Namibia, Rwanda, Seychelles, Sierra Leone, Swaziland, South Africa (for less than 30 days stay), Tanzania, Uganda, Zambia and Zimbabwe. #### Health

A yellow fever vaccination certificate is required only if you are arriving in Kenya from a country with risk of yellow fever transmission. For advice on other vaccinations recommended for visitors to Kenya, please contact your doctor or the UNON Joint Medical Service. Medical costs incurred in Kenya will be responsibility of the meeting participant directly; it is therefore strongly recommended that you arrange own travel health insurance prior to arrival. #### Security

The United Nations Environment Programme, United Nations Office at Nairobi (UNON) and the Kenyan Authorities are working closely together to ensure that all precautionary measures are taken for delegate's safety and security. #### Weather

The average temperature in Nairobi in September is very mild at 17 °C. Afternoons can be fairly hot with average high temperatures reaching 24 °C. Overnight temperatures are generally quite mild with an average low of 10 °C. The average daily temperature range/ variation in September is 14 °C.

#### **Electricity**

The electrical currents in Kenya are 220 - 240 Volts, 50 Hertz. Kindly, note that Kenya uses the 13A 3 [square] wall switch socket outlet.

## Official Languages

The official language of the Republic of Kenya is English and the national language is Swahili.

#### Money and Banking

Currency and exchange rates

The official currency of the Republic of Kenya is the Kenya Shilling (KES). The current exchange rates are approximately: 1 US Dollar = KES 100.50 1 EUR = KES 118. For more information; https://www.centralbank.go.ke/rates/forex-exchange-rates

Foreign currency can be changed at JKIA, which has 24hr service, banks and foreign currency exchange bureaus. Banks with ATM services in major centres across the city are open from 09:00 to 16:00hrs Monday to Friday and from 09:00 to 12:00hrs on Saturdays. There are some malls that have banks that operate on Sunday and public holidays. However, ATM services are more widely available at designated booth locations in the various malls, selected convenience stores at gas/petrol stations.

The following places are available near the UNON compound in Nairobi for currency exchange:

- ➤ Kenya Commercial Bank (KCB) is located on the ground floor in the UNON complex, next to the Delegates Lounge.
- > Standard Chartered Bank is also available in the complex, located opposite KCB Bank

#### **ATMs**

ATMs are available country wide with 24-hour access. Within the UNON complex there are four ATMs on the lower concourse; two next to the Kenya Commercial Bank, one is near the UNFCU (United Nations Federal Credit Union) and the last one is next to Standard Chartered Bank. There are also two ATMs (KCB and UNFCU) at the UN Commissary on the northern end of the UN Gigiri Complex.

Major international cards are accepted.

## About the UNON Gigiri Complex

The Gigiri complex accommodates approximately 3,500 staff members inclusive of the service coordinators. However, during major conferences, the population at the Gigiri complex can exceed 5,000 people.

The 140-acre UN Gigiri complex is a peaceful place, adjacent to the famous Karura Forest. The UN Gigiri Complex has a variety of unique natural habitats and thematic artefacts to see on an organized tour. It also boasts of an ecologically balanced environment, with a set of constructed wetlands with reed-beds and artificial water features, to support its primary wastewater treatment. A designated biodiversity arboretum with an assemblage of indigenous tree species is situated on the southern end of the Complex with interpreted nature trails.

While at the UN Complex in Gigiri, please refrain from feeding the Sykes' monkeys. They are wild animals and should not be fed with any left overs foods meant for human consumption. This is bad for their digestive systems and their teeth, apart from getting them acquire food snatching habits and conflicts with humans.

#### Access to the complex

Access to the UN Gigiri Complex is via the UN Avenue. The main pedestrian access is through the Pavilion, north of the main vehicle access gates opposite the United States Embassy. Vehicles can drop off their passengers at a drive-in space in front of the gate.

All participants need to be registered prior to the meeting to be allowed access. Registered participants will be screened and are advised not to bring weapons, ammunition, flammable items or sharp objects. Participants accessing the UNON complex will be requested to present a valid Government issued photo ID or passport. Participants will thereafter be issued with a conference badge and are advised to wear the badge always during their visit.

The main vehicle access gate is located opposite the US Embassy. Only vehicles with an official UN decal or UN Environment Assembly Decal (which shall be provided to VIPS only) will be allowed into the complex and are subject to screening. These vehicle decals will be issued by the Secretariat during registration.

#### Pre - registration to the AMCEN special session

Once pre-registered online and written confirmation to the Secretariat, delegates will be able to finalize their registration on-site and collect their badges at the UNID Office located at the Pavilion on days designated prior to the session and the session itself.

Paper smart - AMCEN is the main regional environmental decision making body in Africa and will therefore lead by example in all its activities/interventions, by reducing its carbon footprint. Participants and delegates are encouraged to bring laptops or iPads, as most documents will be made available online at: https://www.unenvironment.org/regions/africa/african-ministerial-conference-environment and http://www.nepad.org/aepp. Limited on-demand hard copy of official documents will be made available only upon request in meeting rooms.

Free of plastic cups - To combat pollution, the UNON compound now uses glass water bottles instead of plastic containers. All participants are encouraged to bring their own reusable bottles, as water dispensers will be available at the event, situated in suitable and accessible locations. These steps will reduce the special session's pollution footprint by minimizing waste and its dangerous impacts on the environment and human health.
